Nonresidents need only to file Form 8843, "Statement for Exempt Individuals and Individuals with a Medical Condition" Download form [here](#). Complete and mail.

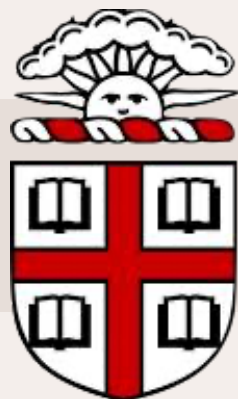

1. Complete your federal tax return in Sprintax for free. Follow step by step instructions within Sprintax Print your return and mail.
 - a. Sprintax will determine your US tax residency status for the tax year based on your current and past immigration history and days spent within the U.S. over the span of multiple years.
 - b. If you are a non-resident for tax purposes, you can use SPRINTAX to assist in filing your state taxes for a fee. NOTE: You are not obligated to use SPRINTAX to prepare your State Income Tax Return. Alternatively, you can prepare and file your State Income Tax Return independently. In any case, you will need to have prepared the Federal Income Tax Return prior to beginning any State Income Tax Return.

3a - How to make the most of your mini consult?

- Have a copy of your completed/partially completed tax return available during your appointment .
- Appointments are for outstanding questions, not an aid to complete or file your returns.
- Appointments are 15 minutes in duration, maximum.
